

PRIVACY POLICY

Welcome to RecommendedCams.com, an internet site owned and operated by Hamoona Technology Development Ltd. ("we", "us" or "our") (the "**Site**"). This document explains the Site's practices regarding the information collected when you use the Site, the manners in which the Site may use such information, and the options and rights available to you. By accessing or using the Site, you signify that you have read, understood, and agree to the terms of this Privacy Policy. This Privacy Policy, together with the Terms of Use found at terms-and-conditions (the "**Terms of Use**") constitute a legally binding agreement between you and the Site. The Privacy Policy is incorporated to the Terms of Use by way of reference and constitutes an inseparable part of the Terms of Use. You hereby represent and warrant that you have read and understood and agreed to be bound by this Privacy Policy and the Terms of Use.

All capital terms herein shall have the meaning ascribed to the in the Terms of Use.

YOU HEREBY ACKNOWLEDGE AND AGREE THAT YOU ARE PROVIDING US WITH INFORMATION AT YOUR OWN FREE WILL, FOR THE PURPOSES DESCRIBED IN THIS PRIVACY POLICY, AND THAT WE MAY RETAIN SUCH INFORMATION IN ACCORDANCE WITH THIS POLICY AND ANY APPLICABLE LAWS AND REGULATIONS. HOWEVER, PLEASE NOTE THAT SOME OF THAT INFORMATION MAY BE REQUIRED IN ORDER TO ENABLE US PROVIDING THE SERVICES THROUGH THE SITE, AND THEREFORE, IF YOU DO NOT PROVIDE SUCH INFORMATION WE MAY NOT BE ABLE TO EFFECTIVLY PROVIDE YOU WITH THE SERVICES.

COLLECTED INFORMATION

The Site may collect two types of data and information:

Non-personally Identifiable Information. This kind of information may be collected by the Site or provided by you without being related to any identified person ("**Non-Personal Information**"). Non-Personal Information may include (but is not limited to): search inquiries, technical information and aggregated usage information, type of operation system, browser type and version, language and keyboard language.

Personally Identifiable Information. This kind of information is namely connected to an identified person or may, with reasonable effort, identify an individual, or may be of private or sensitive nature ("**Personal Information**"). Personal Information may include (but not limited to): your computer's IP address or other persistent user identifier, which is allocated to your device by your Internet service provider, your e-mail address, telephone number, location and demographic information, your first and last name, date of birth, gender, physical address, including zip code, mobile/cellular number, and any other information you

provide to us during the registration process or through the course of communicating with the Site about the products and services provided by the Site.

The Site collects the information from you and from your interaction with the Site, as well as from various other sources such as third parties and publicly available information.

Without derogating of the aforementioned, please note that we may collect any of the following data:

- Your personal information such as Your name, date of birth, gender, contact details (email addresses, telephone numbers etc.) and profession.
- Information about your geographical location.
- Your search behavior and preferences in the Site.
- Information about your devices and access to the Internet (such as IP address, web browser and operating system type and version).

PURPOSE OF COLLECTING THE INFORMATION

We use the Information we collect for the following purposes (the "**Purposes**"):

- Register you to the Site and maintain your account.
- Provide our services, maintain, protect and improve them, to develop new services.
- Offer you tailored content – such as providing you more relevant ads.
- We may use the information for statistical analysis, analytics, research and technical support.
- We may use your email address and your mobile phone number to inform you about landing pages for a variety of services, content and products, including those offered by third parties.
- Make your next use of the Site more personalized.
- Contact you regarding administrative issues, such as questions about your specific request, or otherwise respond to your comments or requests.
- Make telephone calls and send text messages to you with information and offers.
- Track online behavior for behavioral advertising and other marketing purposes.
- Help administer and protect the security of the Site.

- Prevent, detect, mitigate, and investigate fraud, security breaches, and potentially prohibited or illegal activities.
- Enforce this Privacy Policy, and the Terms of Use.

HOW DO WE COLLECT INFORMATION?

We collect information in two ways:

Information you give us. In certain occasions we may ask you to provide certain information about yourself, for example: your name, email address, location information or telephone number. Please note that you are not obligated in any way to provide us with any information, but we may not be able to properly provide you with our services and/or parts of our services if you refuse providing the required information.

Information we get from your use of the Site. We [collect information](#) about your [usage and interaction with the Site](#). This information may include, among other things:

- [Device information](#) (such as your hardware model, operating system version).
- Log information - We automatically collect and store certain information in [server logs](#). This may include (but is not limited to): details of how the Site is used and search queries.
- Device event information such as crashes, system activity, keys and values in the windows registry hardware settings, browser type, browser language, the date and time of your request and referral URL.
- Location information.

YOUR RIGHTS

You may be aware that the European General Data Protection Regulation or "GDPR" gives certain rights to individuals in relation to their personal data. Accordingly, we have implemented additional transparency and access controls in our Privacy Center and Privacy Settings to help users take advantage of those rights. As available and except as limited under applicable law, the rights afforded to individuals are:

- Right of Access - the right to be informed of and request access to the personal data we process about you;

- Right to Data Portability - the right to request a copy of your personal data in electronic format and the right to transmit that personal data for use in another party's service; and

- Right not to be subject to Automated Decision-making - the right to not be subject to a decision based solely on automated decision making, including profiling, where the decision would have a legal effect on you or produce a similarly significant effect.

We will respond to your request within a reasonable period of time upon verification of your identity. If you are unhappy with the way we are using your personal data you can also contact and are free to lodge a complaint with your local data protection authority.

In accordance with the GDPR You have the right to ask for a copy of any personal Data that we hold relating to you.

DATA CONTROLLER

- Hamoona Technology Development Ltd. shall be the data controller of the master data you enter in connection with your creation of a profile on the Site, i.e. your name and your email address, as well as registration of your IP address, your employment preferences, employment searches and other demographic information.
- Note that if you decide to sign up for our SMS job alerts program, you will be asked to provide your phone number. Your phone number will not be shared with 3rd parties unless you explicitly request us otherwise.

COOKIES

We may use cookies that may uniquely identify your browser. You will be prompted to allow Cookies on your first access to the Site. You are not obliged to accept Cookies, however, not accepting Cookies may interfere with you experience with the Site and might prevent us from providing you certain services.

What Are Cookies?

“Cookies” are a feature in your browser software. A cookie is a small text file that is stored on a user's computer for record keeping purposes and to improve your experience. If enabled, we may write cookies that may store small amounts of data on your computer.

How We Use Cookies

Using Cookies is a common practice with many professional sites. When you visit the Site, if your computer and browser allow receiving Cookies, we send you a Cookie to be stored on your computer. By using the Cookie we track certain non-personally identifiable information with respect to your behavior on the Site. Cookies assist us in tracking which of our features appeal the most to you and what content you may have viewed on past visits. When you visit the Site again, cookies can enable us to customize our content according to your preferences. However, be aware that disabling cookies will affect the functionality of this and many other websites that you visit. Disabling cookies will usually result in also disabling certain functionality and features of the Site.

KEEPING PERSONAL INFORMATION ACCURATE

We do our best to ensure that Personal Information that are inaccurate are corrected or erased or rectified without delay. If you become aware of any inaccurate information you have provided us with and/or if there is any change in any information you have provided us with, please let us know of it promptly at contact@RecommendedCams.com, so we may erase and/or correct such information.

STORING INFORMATION AND CROSS BORDER DATA TRANSFER

Personal Information and Non-Personal information collected by Us and/or provided by you ("**Information**") may be stored in two types of locations:

- Local storage - We may store Information (including Personal Information) locally on your device.
- Servers – We may store Information on our servers (and/or third parties' servers we may use for this purpose) (the "**Servers**").

We store Personal Information for longer periods insofar as such Personal Information is required for any of the Purposes.

We do our best to ensure appropriate security of the Personal Information, including protection against unauthorized or unlawful processing and against accidental loss, destruction or damage, using appropriate technical or organizational measures.

HOW LONG WE KEEP INFORMATION

We keep your Information for only as long as we need to. How long we need your Information depends on what we are using it for, as set out in this Privacy Policy. We may also need to keep your Information for accounting purposes. If we no longer need your Information, we will delete it or make it anonymous by removing all details that identify you. You also have the right to ask Us to delete your Information or restrict how it is used. There may be exceptions to the right to erasure for specific legal reasons which, if applicable, We will set out for you in response to your request. SHARING INFORMATION WITH THIRD PARTIES

We may, and by using the Site you agree, consent and approve us to share or transfer Non-Personal Information to third parties.

We may, and by using the Site you agree, consent and approve us to disclose to third parties your Personal Information as set forth below:

- To companies and individuals, we employ to perform technical functions on our behalf.
- To determine what opportunities are right for you. Subject to your consent we may disclose your Personal Information to third parties to provide you with career-related information and to contact you about other opportunities, products or services of third parties.
- The Site uses your Personal Information to determine whether you might be interested in the opportunities, products or services of a particular third party. This

may include business co-operations between the site and third parties for profit ("**Partners**").

- In an event of a merger or acquisition we may disclose and transfer your Personal Information to a third party who acquires any or all of our business.
- In the event we become the subject of an insolvency proceeding, we or our liquidator, administrator, receiver or administrative receiver may sell, license or otherwise dispose of your Personal Information in a transaction approved by the court.

We may also share Personal Information with companies, organizations or individuals if we have a good-faith belief that access, use, preservation or disclosure of the Information is reasonably necessary to meet any applicable law, regulation, legal process or enforceable governmental request, enforce applicable terms of service, including investigation of potential violations, detect, prevent, or otherwise address fraud, security or technical issues or protect against harm to the rights, property or safety of the Site, our users or the public as required or permitted by law.

When you use the Site it may refer your inquiry or link you to a third party provider ("**Provider**"). Any information you provide to a provider or collected by such Provider is subject to the Provider's privacy policy and the Site shall not have any responsibility over such use. Note that if you provide a Provider with certain personal information it may have access to the information we have collected about you.

If you sign up for email job alerts, we will send you job alerts via email. You can unsubscribe at any time. We will share your email address and job-related preferences with the vendor that we use to send you email job alerts. The vendor is located in the U.S., and is Privacy Shield certified, which requires the vendor to provide a similar level of protection for personal data shared between Europe and the U.S.

If you decide to sign up for our SMS job alerts program, you will be asked to provide your phone number. Your phone number will not be shared with 3rd parties unless you explicitly request us otherwise.

In the event we transfer our business or any part thereof to any third party, we may transfer your information to such third party, which may use them under the provisions of this Privacy Policy.

SECURITY

We do our utmost to ensure that all reasonable steps are taken to make sure your Personal Information and data is stored securely in accordance with the principles of the GDPR. Data security is very important to us and to protect Your data we have taken suitable measures to safeguard and secure data collected through our Site. However, please note the Internet and the electronic transmission of information can never be entirely secure. We cannot guarantee that the security measures we have in place to safeguard Data will never be defeated or fail, or that those measures will always be sufficient or effective. Therefore, although we are committed to protecting Your privacy, we cannot guarantee that Your Data will always remain confidential. You understand and agree that you assume all responsibility

and risk for your conduct and use of the Site and the information You send us electronically or otherwise which You post to the Site.
